Risk management is a critical part of my day-to-day work. As a Senior Drilling Engineer, I oversee operations that inherently carry high safety and environmental risks. I conduct regular hazard assessments before operations begin, ensure compliance with safety protocols, and collaborate with HSE (Health, Safety, and Environment) officers to evaluate potential risks like equipment failure or blowouts. For example, during a recent drilling campaign, we identified early signs of gas kick from the formation, and swift adherence to the risk procedures avoided a potential blowout.

During an offshore project, we identified corrosion on critical riser equipment during routine inspections. Rather than waiting for scheduled maintenance, we halted operations, informed leadership, and mobilized a replacement ahead of time. This proactive approach avoided a potential structural failure that could have resulted in environmental and operational damage.

Introducing a formal recognition program for teams that proactively mitigate significant risks could also reinforce positive behaviors.
